You are hereby notified to meet at the Josiah Bartlett Elementary School gymnasium in said District on Tuesday, March 5, 2019 at 6:30 in the evening to act upon the following subjects:

ARTICLE 1: To see if the school district will vote to raise and appropriate the sum of \$8,283,785 for the support of schools, for the payment of salaries for school district officials and agents, and for the payment of statutory obligations of the district. This article does not include appropriations voted in other warrant articles. (Majority vote required) (Recommended by the School Board 4-1-0)

ARTICLE 2: To see if the school district will vote to approve the cost items included in the collective bargaining agreement reached between the Bartlett School Board and the Bartlett Education Association which calls for the following increases in salaries and benefits at the current staffing levels:

and further to raise and appropriate the sum of \$60,305 for the upcoming fiscal year, such sum representing the additional costs attributable to the increase in salaries and benefits required by the new agreement over those that would be paid at current staffing levels <u>under the existing collective bargaining agreement</u>. (Majority vote required) (Recommended by the School Board 5-0-0)

ARTICLE 3: To see if the school district will vote to raise and appropriate the sum of \$14,000 to initiate the next phase of the Technology Program as recommended by the Technology Committee. (Designated as a Special Article) (Majority vote required) (Recommended by the School Board 5-0-0)

ARTICLE 4: To see if the school district will vote to raise and appropriate the sum of \$120,000 to replace the roof of the gymnasium. (Designated as a Special Article) (Recommended by the School Board 5-0-0)

ARTICLE 5: To see if the School District will vote to raise and appropriate up to \$15,000 to be placed in the Capital Reserve Fund (Special Education), previously established for this purpose. This sum to come from the June 30 fund balance available for transfer on July 1, 2019. No amount to be raised from taxation. (Designated as a Special Article) (Majority vote required) (Recommended by the School Board 5-0-0)

ARTICLE 6: To see if the school district will vote to approve the three-year tuition contract with the Jackson School District for the Jackson seventh and eighth grade students to attend the Josiah Bartlett Elementary School. (Recommended by the School Board 5-0-0)

ARTICLE 7: To see if the district will vote to authorize the school board to transfer the St. Joseph Church property at 13 School Street to the Bartlett Historical Society for \$1.00 on such terms and conditions as the school board shall determine are in the best interest of the school district. (Recommended by the School Board 4-1-0)

ARTICLE 8: To transact any other business that may legally come before this meeting.
